- Court highlighted AGM document looks great
- A comprehensive account of organization resilience reflected in 2020
- Looking forward to Public Realm opportunities in 2021
- Good news of Public Washroom on Sparks and working with the Mall Authority on its installation

4. Presentation of the Annual Report and Financials

- Kevin reviewed and presented highlights from the 2020 AGM Report
- Kevin opened the floor for discussion
- Catherine McKenney inquired as how IDA addressed Covid
- IDA and IDA Canada (IDA Canada is in its infancy but being strongly advocated for with its current leadership) approach to Covid aligns with its pre-pandemic narrative that economy is directly linked to social recovery and looking at it as a whole
- For example for the downtown core, there is a lack of green spaces
- In Ottawa the Municipality controls few parks downtown and Federal parks have major control a lot of what they can and can't do in the space

- Kevin referred to our efforts to become the downtown community's front lawn, a place where third parties can activate with a tiered cost system. A third party event policy will be created for 2021 to reflect this and Sparks Street will assist partners if need be. For example charities, non-profits vs corporate activations
- Sparks Street offers a unique opportunity for outdoor space and looks forward to the return of the Design Review Committee for the Public Realm Pilot elements

7. Other Business

- Court referred to OBJ article with regards to vacancies for offices in the downtown core based on a recent report (link: https://www.obj.ca/article/real-estate/non-residential/capitals-office-vacancy-rate-jumps-87-q4-2020-sublease-space) and put forward the question – are we seeing any occupancy trends?
- Michael Swan replied that there is activity for smaller spaces
- We have already provided 8 months of free rent
- There have not been a lot of expiries on the 10 year leases
- The downtown core will come back; ground floor retail
- Gone are the days of cubicle farms but office spaces will be designed for collaboration, open board room style more of a meeting space
- Court asked if there will be interest in the indoor mall format or if retailers will move away from this model for easier control and outdoor access
- Bill responded that there is a lot of interest on Sussex as many retailers know where the best spots are in the city
- Sparks Street is next on their list to promote once Sussex is filled
- No new office deals, but surprised by the retail interest; it's a positive

8. Round Table

- Court suggested the Sparks Street AGM Report be sent to Council as an example of the resilience of the organization during the Covid pandemic
- Councillor McKenney agreed
- Kevin responded that all documents are sent to the City for public access
- Court suggested this would be sent separately, suggested Live Council
